Dear Christy:

Thank you for your message and clarifying all of this. I reviewed the TORs and do have a few questions/reactions on the process for this appeal, from the viewpoint of indigenous peoples' rights. I also understand that this is the first time that you are implementing this Appeal process, so these are factors which may affect its legitimacy and effectiveness.

Content/Process Considerations

- Have you considered providing for non-voting subject matter experts?
- Do all Committee members have experience on indigenous peoples' rights? What was the criteria for selecting them?
- In Section IV, paragraph 15, the TORs refer to "Article 3.1 of the Guidance"? The Guidance is also mentioned in several sections of the TOR's. Has this Guidance been seen by the Amerindian People Association (APA)? It is important that this process fully meets FPIC requirements. This means that all parties involved are aware in advance of any guidance that may be applicable to the process.
- Has the APA been informed previously of all the conditions laid out in section VII? Have they been offered the opportunity to submit comments on these TORs in general?
- In terms of the written record that the Committee will be considering, is there a possibility to consider external documents?
- Can the appeal consider substantive issues raised in the complaint?
- Will the Committee have the authority to issue recommendations for the ART Secretariat to implement?
